TAXES AND CONSEQUENCES

Everything you do has tax consequences. If you buy a car, get a new job, get married, have children, open a business, there will always be taxes to pay and sometimes credits. **Faith Maldonado** from H&R Block shared some of the new tax changes for 2023 and moving forward.

Faith first shared information on the Inflation Reduction Act of 2022 which provides credits for clean air vehicles. There are \$3,750 credits for vehicles that meet the critical mineral requirement components and those that meet battery component

requirements. There are also tax credits available if you choose to have a battery charging station built at your house for your clean air vehicle.

The Previously Owned Clean Vehicle Credit will provide a \$4,000 credit for clean air vehicles sold for \$25,000 or less. In addition, the model year must be no more than two years old at the time of sale. The credit applies to qualified vehicles purchased anytime in the 2023 calendar year.

Included is the Energy Efficient Home Improvement Credit which will give a credit for 2022 of up to \$500 to individuals

for non-business energy property. For 2023, the annual credit limit will be increased to \$1,200 per taxpayer and \$600 per item of qualified energy property.

For those thinking of installing solar in 2023, it will provide a 30% tax credit (over 26%) through 2032. After that, the credits will decrease by a smaller amount each year. Also in 2023, taxpayers may claim a credit for qualifying battery storage technology with a capacity of at least three kilowatt hours.

For businesses that buy clean air vehicles,

there is a 15% credit available for cars that run on both electricity and gas. In addition, there is a 30% credit for a strictly electric or hydrogen fuel cell vehicle. For contractors and manufacturers, there are deductions for electric lighting, HVAC systems and more. In addition, for newly constructed homes, the New Energy Efficient Home Credit has been extended.

Additional tax law changes include educator expenses increased to \$300, the Secure 2.0 Act, and Federal Student Loan Relief, which is currently in litigation. The Secure Act 2.0 addresses employer retirement accounts, credits, and catch-up contributions. In addition, there are more exceptions to the 10% penalty for early retirements, plus credits for public safety officers and employees.

If you deal Cryptocurrency and NFT's, the Government will get their fair share and you will be taxed on those type of currency this year. In addition, if you get paid for your business through PayPal, Zelle and others, there will be a tax levied there too.
