

# HOW TO GET OUT OF A TRAFFIC TICKET

Retired Family Law Judge **Kirt Mahlum** entertained Rotarians this week with several more stories from his experience as an attorney and Judge. He graduated from law school 50 years ago; on the bench for 17 years and retired about 5 years. He still does mediations, and highlighted some facts of interest. He moved to Barstow in 1951 or 1952 with his dad, and told how his dad, also a Federal Magistrate, and the DA at the time would fly his plane





Kirt had some advice for receiving a traffic ticket... "Trial by Declaration" if you don't qualify for traffic school. Remember the other side has to prove its case beyond a reasonable doubt, and quite often, the officer is unavailable to show up, or maybe hasn't filed his statement. A guilty verdict will be rendered, and there's no need to lie; the prosecution is unable to prove its case beyond a reasonable doubt. However, if you are

found guilty, best to request a trial. Case must be dismissed if the officer doesn't show up for court, which happens quite often. Also, don't ever agree to a continuance just because the officer doesn't show up! Another suggestion for a speeding ticket, ask the officer politely if they would agree to a lesser ticket or speed, because it never hurts to ask. Officers are human, after all.

Kirt shared a couple of great speeding excuses: "I was running out of gas" and "I had to go to the bathroom".

Kirt's experience comes from a variety of law including juvenile court, probate, law and motion, and criminal. His most favorite types of court proceedings are weddings and adoptions and his favorite kinds of court cases are those with very good attorneys. He loves to watch them "go at it, legally".




It was a great meeting with week with **Kirt Mahlum** returning to the Club to share some more great stories. I thought it was quite apropos to present him with

As a divorced man, he discussed the pain and frustration



for everyone in a divorce proceeding; he always pushed for speed, as mediations that drag on get very expensive. He was the Family Law Department in Barstow, where the local attorneys as well as the families involved appreciated an expeditious outcome.

Kirt was very serious in excessive speed cases, however, and would often have the speeder look at the "Death Book" Kirt had made up of horrific, gory photos of people and children killed in accidents involving high speeds.

Kirt answered some questions and concluded with some sound advice to all involved in court proceedings: Be prepared - Be polite – Be organized. Hire a local attorney, and don't hesitate to use a Public Defender in an average, not too serious case.
