THE MANY LEVELS OF INSURED FUTURES

Covid has affected all businesses and industries but for a multiple level industry such as insurance, it has very distinct challenges, as was shared by Rotarian and ISU Insurance Services - ARMAC Agency Chief Executive Officer **Ryan McEachron**. ISU ARMAC is a multi-line insurance company that handles not only residential and commercial lines of insurance but



benefits as well. At the meeting, Ryan gave a few examples of the changes that affect different types of insurance and benefits.

Personal Auto Insurance – Rates went down due to people not driving during the pandemic. As the work force continues to work from home this will continue in the future.

Personal Property Insurance – While not related to Covid, due to the heavy brush fire season, the property market is extremely volatile in California. Due to wild fires getting worse, many companies are pulling out of certain areas and will not write any homes considered near brush, like in the High Desert. Ryan expects this to only get worse until the State can figure out a way to prevent these fires.

Commercial General Liability – Although he has not seen many claims for Bodily Injury or Property Damage, Ryan does expect

that there will be some that come in the future. People will claim that they contracted Covid in a place of business and if a family member died as a result the owner as a business could be sued for wrongful death. This all done in hopes of getting an out of court settlement. It will be interesting to see how this plays out over time.

Workers Compensation – Covid claims dominated 2020. If an individual contracted Covid and said they got it at work it was assumed they did. All claims were accepted without any requirement of proof. Should Covid stick around that assumption will stay in place and when, not if, another pandemic happens, this will continue to be the case.

Medical Malpractice Insurance – As hospitals had to turn away patients due to overcrowding and non-covid related procedures and surgeries were not performed, the expectation of lawsuits to follow against doctors and hospitals for not treating people is highly likely. Most will just settle but this will drive up the cost for this insurance.

Commercial Property – This is the big one. Many claims have been filed for Business Interruption Insurance. This is basically loss of income insurance due to having to shut down. Insurance companies have denied these claims as it is not considered a Direct Physical Loss (i.e., Fire, Theft or Vandalism) that shut them down. Many claims were filed, especially in the Restaurant Industry, who used the argument that Covid on a counter-top, table or bar was actually Direct Physical Loss. Numerous lawsuits have been

filed against insurance companies to force them to pay out on these claims and although some courts have upheld that there was no "Direct Physical Loss", others have allowed the cases to move forward. We won't know the full outcome on this issue until a case makes it to the Supreme Court.

Finally, the Dental Industry, was affected too by Covid, but not in the negative. Because not much dental work was done last year, most dental insurance companies made a killing in 2020 because very few claims were filed.

Victor Valley Transit Authority Executive Director **Kevin Kane** had another week with the Spoon and shared that VVTA is moving and evolving in 2021 and beyond. As previously mentioned, the Victorville Hub that has been at Lorene and Seventh for the last five years behind Costco will now be moving down the street to the Victor Valley Transportation Center at

16838 D Street on August 1st. Considering the recent rise in Covid numbers due to the Delta Variant, VVTA has made the difficult decision to cancel their scheduled Ribbon Cutting at the Victor Valley Transportation Center set for August 2nd. If and when a new date is set, Kevin will make a formal announcement to the Club.

Also due for expansion will be VVTA's Hesperia Facility. Recently the organization purchased 2.7 acres directly to the north, which will expand the facility to include a new Hesperia Transportation Hub, a move away from the current location at the Hesperia Post Office.
