the Governor's desk. Jay O b e r n o l t e has 4 more Bills right now that are past Assembly and are in the Senate.

His biggest challenges await him as he is about to go into two Special Sessions where he will truly have his work cut out for him to assist the people he serves from Temecula to Needles.

The first special session deals with healthcare. The tax on Medicare Insurance Plans is about to expire and California wants to tax ALL Health Care plans as a result. Jay is vehemently against this and will fight against it

The second Special Session deals with our California road infrastructure. Let's face it, our roads need help and the taxes used for road repairs are not in the funds they should be. California wants to either raise gas taxes again, raise Vehicle Licensing Fee taxes or start taxing electric cars. Our state has the second worst roads in the country and second highest gas tax. The question Jay will ask in this session is, "How is this disparity happening"? His solution is to change things. Commercial Vehicle Weigh Fees are supposed to roads, but right now are going into the General Fund. Sales Tax on diesel fuel is supposed to go 100% to transit, but instead it is going to the Cap & Trade Fund. Jay will work tirelessly to change this situation, and get our California roads back to where they need to be.
