to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defense."

Whenever someone asks San Bernardino County Public Defender **Chris Garner** how he can look at himself in a mirror, and defend the people he does, he just remembers the above amendment that everyone, deserves representation. One common misconception

about the Public Defender's office is that those attorneys are ones that barely made through laws school and cannot get a job at a real firm. In fact Chris, along with other attorneys in the Public Defender's office went to Law Schools and passed the BAR with high scores, strictly to be Public Defenders. His philosophy to himself and his staff is quite simple: Make sure to vigorously represent who the court gives them, fight hard, but most importantly, do it ethically.

Chris sees his department was watchdogs for the judicial

system, and that system wouldn't work without their part in the process. He has a lot of respect for the District Attorney's office, as both of their sides are equally as passionate to prove their cases, which is the way it should be in the Judicial system. In fact, with our country divided among many lines nowadays, our Justice System is still the great equalizer and makes us the greatest country in the world, but they don't go at it alone.

The County office has a whole team working with them. They practice a holistic type of approach, which is client centered. They get to know their clients lives, and what got them into the system and work

hard to keep them from returning, whether the case is a win or a loss.

The Public Defender's Office has 16 social workers on staff, who meet with clients and figure out what led them to be charged with the crime.

While Chris and his team are experts inside the courtroom, they also have a team of investigators to work with them in the field to study police reports and make sure the District Attorney didn't miss anything in their pursuit of a conviction, as well as making sure all investigations from law enforcement were conducted ethically.

Finally, if one of their clients is found not guilty, they work hard to have that individuals record expunged, so they can get a job and move on with their lives.
