

# September 12, 2023 THE BEST AND WORST JOBS IN THE WORLD

This week the Club welcomed David Greiner from the Greiner Law Group to share information about Trusts and how they can help and hinder your loved ones. Trusts are powerful legal instruments that enable individuals to manage and protect their assets, provide for their loved ones, and achieve various financial and estate planning goals. David simplified it by stating that a Trust is like giving someone an item of yours to hold, and in case you pass away, then they have to then give it to someone else. At their core, trusts involve three key roles:



the truster (also known as the grantor or settlor), the trustee, and the beneficiary. Understanding how these roles interact is crucial when establishing and managing a trust.

The truster is the person who creates the trust and contributes assets to it. These assets can include cash, real estate, investments, or other valuable property. The truster defines the terms and conditions of the trust in a legal document known as the trust agreement or deed. This document outlines how the trust will operate, who the beneficiaries are, and the trustee's responsibilities. The truster's primary responsibility is to ensure that the trust's objectives align with their intentions and to provide clear instructions for the trustee to follow.

David called the Trustee the worst job in the world, because the trustee gets to hold the property but gets nothing from holding it. The individual or entity responsible for managing and administering the trust on behalf of the beneficiary. This role carries significant legal and fiduciary responsibilities. Trustees must act in the best interests of the beneficiaries, following the instructions set out in the trust agreement. Their duties typically include investing trust assets, distributing income or principal

as specified, and ensuring compliance with relevant laws and regulations. Trustees must exercise prudence, diligence, and impartiality in carrying out their responsibilities. Depending on the trust's complexity, a trustee may also need to file tax returns and keep accurate records of all transactions.

Beneficiaries are the individuals or entities for whom the trust was created. They can be family members, friends, charitable organizations, or even the truster themselves. Beneficiaries have a vested interest in the trust and are entitled to receive the benefits specified in the trust agreement. These benefits can include income generated by trust assets, periodic distributions, or the transfer of trust assets at a specified time or event. Beneficiaries can also have a say in trust matters if the trust agreement allows for their involvement or input.

In summary, trusts are a flexible tool for managing assets and achieving various financial and estate planning goals. The truster defines the trust's purpose, the trustee manages the trust assets, and the beneficiaries reap the benefits. Effective communication among these parties and a clear, well-drafted trust agreement are essential for ensuring that a trust functions as intended, providing peace of mind for all involved.
